Pension payment information

Payment dates

The dates that your pension will be paid into your bank account during 2019 are below. Payment dates for January to March 2020 will be included in the pensioner section of our website ([pensions.cambridgeshire.gov.uk](https://www.pensions.cambridgeshire.gov.uk)) as soon as they are available.

Payslips

Payslips are currently issued every March, April and May. After that you will only receive a payslip when:

- there is a change in your net payment of £5 or more from the previous month;
- you have told us about a change of address; or
- your tax code has changed.

Income tax

Following the annual increase in state pensions, it is usual for HM Revenue & Customs to adjust the personal tax code of those pensioners who receive state retirement benefits. Usually, any new code issued for this will be applied in April or May and may result in a change in the amount of tax you pay from your pension.

Pensions revaluation 2019

Each year, the pension that you receive from us is usually increased in line with the cost of living. This is based on the Consumer Price index as assessed over the previous year, to 30 September. The next increase to your pension is due to take place on 8 April 2019.

At the time of writing, a formal announcement about the Pensions Increase for 2019 has not been made however, if the same method is used to set the Pensions Increase as was used previously, we would expect the pensions increase to be 2.4%.



New online pension account now available

We are pleased to announce that pensioner members of the Cambridgeshire Pension Fund can now access their pension account online through our website. We believe this will make it easier for you to find information exactly when you need it. You will be able to access your payslips, check your personal details and more by logging in to your online pension account. Using your pension account online also has the following benefits.

- You can check and amend your death grant nomination.
- All communications we send you will be uploaded and stored securely in your online account.

How do I register?

You will need to register to access your account, if you have not already done so. Follow these three simple steps.

1. On the homepage of our website, select the Login/Register link to request an activation key. If we have the email address you have registered with, the activation key will be sent instantly. If we do not have your email address, we will send an email to the address you are registered with, asking for further information to confirm your identity.
2. Once you have received the activation key, you can complete your registration by selecting 'complete your registration' after following the link in your email.
3. To log in, enter your user name and password and you will be able to access your information.

Please visit pensions.cambridgeshire.gov.uk and enter the member's portal, then click on Login/Register to get started.



In the future, our aim is to communicate with you as much as possible electronically. We believe that this is a faster, more secure and more convenient way to communicate with you. You will be able to keep and access communications electronically, as they will all be saved in your online pension account. This removes the risk of communications being lost in the post or sent to the wrong address, if you move home and forget to tell us.

Nothing will change immediately and we will write to you again before moving to electronic communications. When we do make the switch, if you still want to receive communications by post, you will be able to opt out of electronic communications by telling us in writing. But there is no need to take action just yet.

National Fraud Initiative



Cambridgeshire County Council act as the administering authority for the Cambridgeshire Pension Fund and are required by law to protect the public funds we are responsible for. Your information may be shared with other bodies responsible for auditing or administering public

Information for your next of kin

The following information is for your next of kin or the executors of your estate. Please cut out this section and keep with your will or other information to be used in the event of your death.

If you are dealing with the estate of a relative who receives a pension from us, you should tell us as soon as

possible if they die. This makes sure any dependants' benefits are paid promptly, and also keeps pension overpayments to a minimum. We will need the following details of the pensioner.

- Name, address and date they died
- National Insurance number
- Name and address of next of kin
- The name and address of the person dealing with the estate, if not the next of kin
- Details of any dependent children
